LewisGale Medical Center located just outside Roanoke, Virginia in Salem, is a 506-licensed bed facility serving as a regional referral center for comprehensive medical services.

The LewisGale Medical Center Transitional Year residents will receive full access to all areas of the inpatient facilities and will be supervised 24-hours daily, 7 days per week by board certified physicians within fully staffed units. Residents will receive a robust clinical and education training experience through participation in providing care to a diverse patient population with ranging acuities and annual volumes averaging over 70,000 each academic year.

The Transitional Year residency program will join four additional ACGME-accredited residency programs based at LewisGale Medical Center: Internal Medicine, Family Medicine, Emergency Medicine, and Psychiatry. The diversity of learners across multiple medical specialties allows residents the ability to co-teach, practice interdisciplinary learning, and collaborate to improve and innovate quality and processes within LewisGale Medical Center.

The Transitional Year program aims to

1. Provide a comprehensive curriculum to develop compassionate, highly competent, patient-centric, and ethical residents with foundational knowledge in disease prevention, and the diagnosis and management of patients.
2. Provide resident with the tools to develop relationships and collaborate with colleagues across the professional continuum.
3. Provide residents with the tools to have a strong impact on public health through community education and to become advocates for disease prevention.

4. Provide residents with the knowledge necessary to incorporate scholarly activity into their evidence-based practice.
5. Develop well-rounded residents who demonstrate knowledge, skills, and behaviors essential to enter categorical training.
6. Establish a strong foundation and promote lifelong collegial mentorship to help develop future leaders.
7. Ensure each Transitional Year resident is provided the prerequisite education for successful training, board certification, and careers in their chosen specialties.

## Rotation Schedule

The Transitional Year residency at LewisGale Medical Center is characterized by a broad range of supervised inpatient and outpatient clinical experiences with a patient population that has a wide spectrum of health concerns.

The training year also provides exposure to core disciplines as well as the specialty. Education is provided in medical / surgical experiences while incorporating formal and informal methodology.

Each rotation has scope, volume, and variety to allow trainees to meet standards and program objectives.

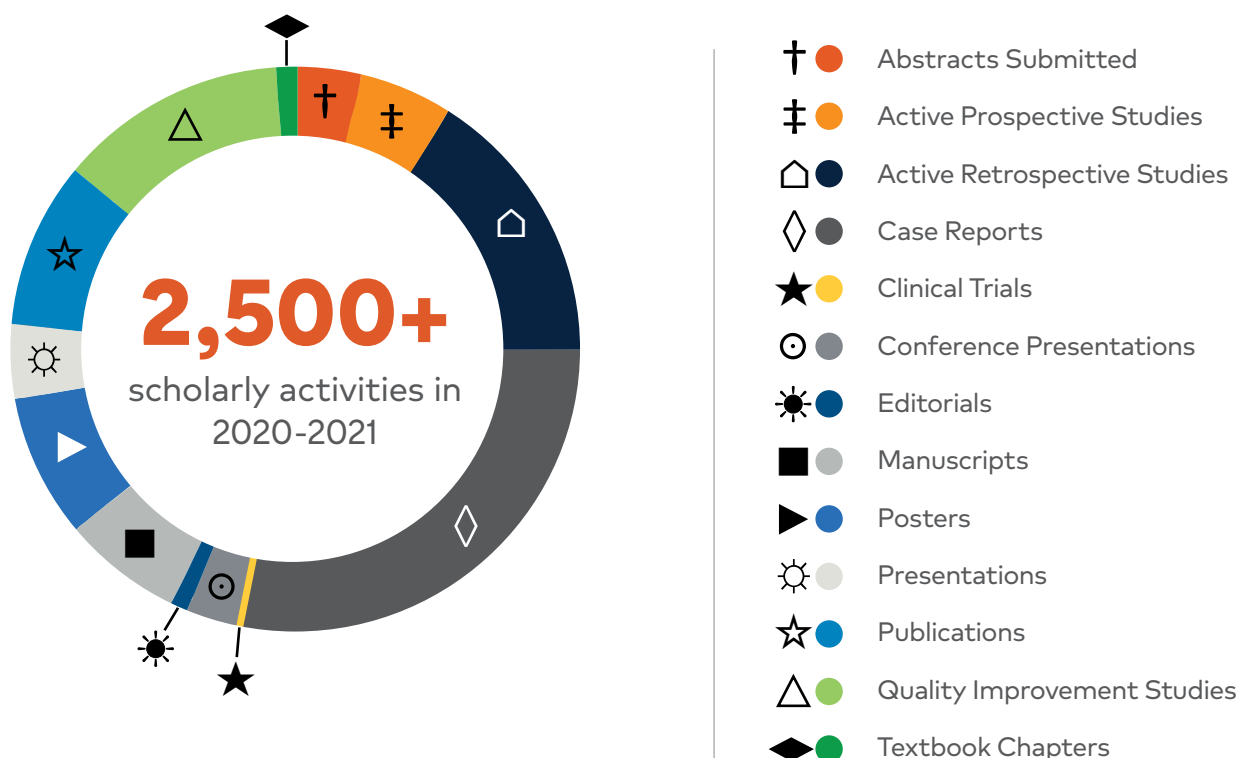
